REGULATIONS – BALL PARK

The following Regulations have been made by the Town Council of Long Harbour-Mount Arlington Heights under the Provisions of Section 178 (2) of the Municipalities Act, SNL 1999 and were approved by Council on the 25 day of July, 2016.

REGULATIONS

Interpretations: In these regulations unless the context otherwise requires:

- (a) “Act” means the Municipalities Act, SNL 1999.
- (b) “Council” shall mean the Town Council of Long Harbour-Mount Arlington Heights.
- (c) “Town” means the Town of Long Harbour-Mount Arlington Heights.
- (d) “Park” meaning the James J. Griffiths Jr. Memorial Park including the Ballfield, Playground, Basketball Court and Walking Track.
- (e) “Recreation Committee” means such committee as is appointed by the Town Council of Long Harbour-Mount Arlington Heights.
- (f) “Employee” means any person employed by the Town Council.

1. The Ball Park shall be open to the public year around.
2. No person shall drive ATV’s, dirt bikes, ski-doo’s or any other motorized vehicle through the Park.
3. Barbecues or other entertainments may be held at the Park with prior permission from the Sports & Recreation Committee
4. No person shall remove, destroy, mutilate or deface any structure, wall, fence, railing, seat, tree, shrub, fern, plant, flower, or any other property in the Park.
5. Nor person shall walk, stand, sit, or climb on any border, fence, dugout, or railing within the Park.

6. No person shall take or attempt to take from within the Park any bird or bird's egg from a nest, nor set any trap, nor use any other means for taking same.
7. No dog or other animals shall be allowed in the playground, ballfield, or basketball court area except under leash in the picnic area or walking track.
8. All persons shall clean up after their dogs when walking them in the picnic area and walking track.
9. No unauthorized person shall sell or offer for sale any commodity whatsoever in the Park and no money shall be solicited or collected in the Park except by permission of the Sports & Recreation Committee.
10. No unauthorized person shall offer for consumption any intoxicating liquors within the Park.
11. No person shall park tractor trailers, camper trailers or motorized campers overnight on parking lots without permission of the Town Council.
12. Picnic tables shall not be removed from the Park without prior permission from the Town Council.
13. Any person or organization wishing to use the ballfield or Park may do so with prior permission from the Sports & Recreation Committee.
14. Except in the waste cans and receptacles provided for debris, no person shall deposit or leave in the Park any bottles, broken glass, crockery, refuse, paper, or other matter.
15. Any person who uses any area outside of toilet facilities provided shall be liable to the penalty hereinafter imposed.
16. Any person resisting or refusing to obey the lawful orders of the Sports & Recreation Committee, Town Council or its employees shall be liable to the penalty hereinafter imposed.

Penalty

17. Any person guilty of a breach of any of the foregoing regulations shall be liable upon summary conviction to a minimum fine of twenty-five dollars (\$25.00) or in default to imprisonment not exceeding thirty days.

These regulations shall come into effect on the 25 day of July, 2016 and may be cited as the Town Council of Long Harbour-Mount Arlington Heights Ball Park Regulations, 2016.
